Waiver and Release of Liability and Claims, and Covenants Not to Sue

Wolf Conservation Center Inc. is a non-profit corporation located in the State of New York (hereafter referred to as the "WCC").

In consideration for and as a condition of my/our minor child being permitted to enter and use the property of the WCC (the "Property"), I/we, on my/our behalf and on behalf of my/our minor child and my and she/he/their heirs, assigns, executors, next of kin and personal representatives hereby fully, finally and forever **WAIVE, RELEASE, INDEMNIFY, HOLD HARMLESS AND DISCHARGE** the WCC and any and all of ITS parents, subsidiaries, affiliates, predecessors, successors, assigns, divisions, departments, and any and all of their past or present shareholders, directors, trustees, officers, partners, employees, agents, insurers, coaches, teachers, instructors, volunteers, representatives, and any other person(s) acting or purporting to act on their behalf (such parties together with the WCC are hereafter collectively referred to as the "Released Parties"), from any and all claims, actions, causes of action, lawsuits, demands (whether written or oral), obligations, debts, damages, liabilities, losses, costs, interest, expenses, and/or attorneys' fees, whether in law or in equity, whether foreseen or unforeseen, whether known or unknown, whether hidden or concealed, whether suspected or unsuspected, and/or whether based on federal law, state law, common law, statute, and/or any other law, rule or regulation whatsoever, arising from, connected with, or in any way relating to my/our child's presence or participation in any of the activities conducted by WCC, on the Property of the WCC, or for the benefit of the WCC (the "Claims"). Notwithstanding the foregoing, this waiver and release of liability does not apply to any acts of gross negligence, or intentional, willful, or wanton misconduct, by the WCC. This means, in part, that I/we are/am releasing unknown future Claims.

I/we hereby **COVENANT** and **EXPRESSLY AGREE** that I/we **WILL NOT SUE OR MAKE ANY CLAIM** against the Released Parties for any injuries, damages, and/or other losses incurred or sustained as a result of my/our child's participation in any of the activities conducted by WCC, presence on the Property of WCC, or for the benefit of the WCC.

I/we **AFFIRM** that I/we and my/our minor child am/are currently covered under appropriate general liability and personal health insurance policies issued through a licensed insurance carrier.

I/we **EXPRESSLY ACKNOWLEDGE, AGREE AND UNDERSTAND** my/our child's presence and participation in activities on the Property have inherent risks and dangers and no amount of care, caution, diligence, instruction, or expertise can eliminate these risks and dangers, and I/we, on my/our behalf and on behalf of my/our minor child, **EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE MY/OUR MINOR CHILD IS PARTICIPATING IN SUCH ACTIVITIES ON THE PROPERTY.** I/we acknowledge, agree, warrant, and represent that I/we understand the nature of the activities in which my/our minor child will participate, and that my/our minor child is in good health, qualified, and in the proper state of mind to safely participate in said activities. If at any time I/we find my/our minor child no longer qualified in any sense, or find (in our opinion) these activities to be unsafe in any way, shape, or form, I/we will immediately discontinue my/our minor child's participation.

I/we further **EXPRESSLY AGREE** the foregoing waiver, release, indemnity, and covenant not to sue agreement is intended to be as broad and inclusive as is permitted by the law of the state of New York and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force.
