DEVEN AND THE SEVEN OTHER WOLVES CHOSEN FOR RELEASE (THREE ADULTS, FOUR PUPS) WERE SELECTED FOR THEIR GENETIC VALUE AND THEIR ESPECIALLY ELUSIVE BEHAVIORS.
